
**SUB: MOTOR VEHICLES - Goods Vehicles - Over load -  
Implementation of Section 113 & 114 of M.V. Act 1988 -  
Supreme Court of India Order in W.P. (CIVIL) No.136 of  
2003 - Not to Overload at Loading Point - Reg.**

This Office has been receiving complaints that Oil Storage Firms and Transporter are involved in Over-Loading the Vehicles beyond the permissible capacity. The Over-Loading causes damage to Road infrastructure and one of the causes for increasing number of road accidents and Air-Pollution.

According to Sec 113 and 114 of Motor Vehicle Act 1988, Over-Loading should be avoided. Also Hon'ble Supreme Court of India ordered to avoid the Over-Loading of Vehicles.

Moreover, according to Dock Workers (Safety, Health & Welfare) Regulation, 1990, the Trucks and other equipment shall not be loaded beyond their safe carrying capacity.

In this connection, over-Loading at Loading Point should be avoided and any violation of the same shall be viewed seriously.
