TRADE NOTICE : 01/2018

Sub : CONCESSION ON VESSEL RELATED CHARGES FOR CONTAINER VESSELS FOR THE PERIOD FROM 01/04/2018 TO 31/03/2019.

Chennai Port is happy to announce the extension of the following schemes of concession on Vessel Related Charges to the Container Vessels for a further period of one year from 01/04/2018 to 31/03/2019.

- 1) 15% concession on Vessel Related Charges to all Container Vessels has been extended for a further period of one year from 01/04/2018 to 31/03/2019.
- 2) **CONCESSION FOR SHORT HAUL CONTAINER SERVICE:**

Additional concession in VRC ranging from 2% to 15% for Container Vessels between Chennai-Colombo and / or Chennai-Singapore-Port Kelang sector is extended for a further period of one year from 01/04/2018 to 31/03/2019 as tabulated below

3) CONCESSION FOR LONG HAUL CONTAINER SERVICE:

Additional concession in VRC ranging from 5% to 40% for Container Vessels other than Short Haul Container Services (i.e. services to far east, gulf / Mediterranean, Europe, Australia etc) is extended for a further period of one year from 01/04/2018 to 31/03/2019 as tabulated below

The concession for both Short Haul Container service and Long Haul Container Services are extended on the same terms and conditions stipulated for the year 2017-18 except for the modification on the following conditions:

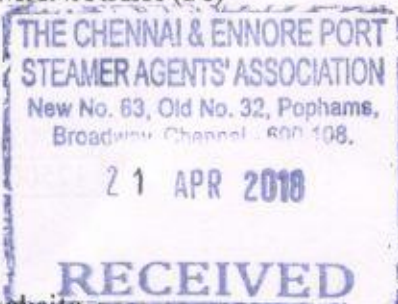
- The claim for refund shall be lodged within 21 Port working days from the date of sailing (including) in the prescribed form along with a copy of the PANS.
- Minimum 50000 TEUs per annum or 80% of the highest volume handled by the service during the previous two financial years viz. 2016-17, 2017-18 through Chennai Port, whichever is higher, should be handled by the Short Haul Container Service during 2018-19.
- The Long Haul Container Service should have handled 80% of the highest volume handled by the service during the previous four financial years i.e 2014-15, 2015-16, 2016-17 and 2017-18 during 2018-19.

The Trade associations are requested to bring the contents of the Trade Notice to the attention of their members, trade and everyone concerned.
